To Dow Constantine:

On behalf of the South Park Neighborhood Association, I am writing to urge you to collaborate with the City of Seattle to effect the transfer of the responsibility for the South Park Bridge and the annexing of the "sliver by the river" and the Duwamish Triangle (Area Q). We are gratified that the King County Boundary Review Board has denied the City of Tukwila's application to annex the Duwamish Triangle.

South Park has expected that once the new South Park Bridge construction is completed that the City of Seattle would assume the responsibility and expense for operation of the bridge. That assumption of responsibility would include annexation of the unincorporated areas surrounding the bridge, which includes the "sliver by the river", as well as the Duwamish Triangle. The City of Seattle and King County have negotiated in good faith to bring this long awaited annexation to pass. The Duwamish Triangle is contiguous with the "sliver" and must be included in the annexation by Seattle.

This annexation will solve a long-standing life safety threat to the South Park neighborhood residents who live in the sliver, as well as providing a much greater degree of safety to the businesses in Area Q. There is greater Seattle police presence in the rest of South Park than there is Sheriff deputy presence in the sliver, or in Area Q. Fire response times in the sliver and in Area Q are greater than response times by the Seattle Fire Department to the rest of South Park. Sliver residents face many other less important but constant annoyances with every other aspect of living in an urban area but having to deal with King County as if we were in a rural area. Likewise, the industrial users in Area Q will greatly benefit from better access to SPD and SFD.

The residents of South Park are an active group with a long history of partnering with the City of Seattle to make improvements within our community. We wish to preserve the cohesiveness of our neighborhood and ask that you please support rapid Annexation of the "sliver by the river" and Area Q into the City of Seattle.

Please accept this letter of support from the South Park Neighborhood Association (SPNA) for the current King County EPA Brownfields Grant application. SPNA is a nonprofit neighborhood organization that improves quality of life in the South Park neighborhood for those who live, work and play here through representing the community and working with all collaborators on neighborhood issues.

SPNA has established strong working relationships with King County elected officials and departmental staff. Together, we sought and found \$131 million to replace the South Park Bridge. We will work with the King County Brownfields Program staff to conduct assessment of brownfield sites in our neighborhood.

South Park is fascinating mix of industry, commercial and retail businesses and residences. We also have the highest percentages of diversity of any neighborhood in Seattle. Data show that the health and life spans of South Park residents are worse than other neighborhoods in Seattle. It will be helpful to our association to identify potential environmental problems on sites we have targeted for remediation and future development. SPNA will work with King County to help identify additional sites; conduct outreach to citizens on assessment projects; obtain community feedback; provide project updates, including distributing assessment fact sheets; and provide information to the county on ongoing status of cleanup and redevelopment, as appropriate. We will use our social network sites to reach our members and reach others through distributions at food bank lines and the like.

Thank you for considering King County's grant application. The South Park Neighborhood Association supports the application and the continuation of the county's Brownfields Program.

Dear Boundary Review Board,

At our recent South Park Neighborhood Association meeting on October 9, 2012, the membership voted unanimously to oppose Tukwila's proposal to annex the Duwamish Triangle.

South Park has known that once the new South Park Bridge construction is completed that the City of Seattle would assume the responsibility and expense for operation of the bridge. That assumption of responsibility would include annexation of the unincorporated areas surrounding the bridge, which incorporates the "sliver by the river" as well as the Duwamish Triangle. The City of Seattle and King County have negotiated in good faith to bring this long awaited annexation to pass. The Duwamish Triangle is contiguous with the "sliver" and must be included in the annexation by Seattle.

If the Duwamish Triangle is annexed into Tukwila, we are concerned that Tukwila police and fire wouldn't be able to adequately serve the Triangle, and it would further isolate the "sliver". If Seattle were to annex both the "sliver" and the triangle, it would bring better service to South Park and ensure the safety of our neighbors.

The residents of South Park are active users of the South Park Branch of the Seattle Public Library as well as the South Park Community Center (also operated by the City of Seattle). We are an active group and have a long history of partnering with the City of Seattle to plan neighborhood celebrations and to make improvements within our community. We wish to preserve the cohesiveness of our neighborhood and ask that you please deny Tukwila's request to break up our community by singling out the Duwamish Triangle for annexation.
